2. RESOLUTION 1 – ADOPTION OF REMUNERATION REPORT

"That, for the purposes of section 250R(2) of the Corporations Act and for all other purposes, approval is given for the adoption of the Remuneration Report as contained in the Company's annual financial report for the financial year ended 30 June 2021."

3. RESOLUTION 2 – SPILL RESOLUTION

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

"That, for the purposes of section 250V(1) of the Corporations Act and for all other purposes, approval is given for:

- (a) the Company to hold another meeting of Shareholders within 90 days of the date of this Meeting (**Spill Meeting**); and
- (b) all Vacating Directors to cease to hold office immediately before the end of the Spill Meeting; and
- (c) resolutions to appoint persons to offices that will be vacated pursuant to (b) to be put to vote at the Spill Meeting."

Note: The Chair will withdraw Resolution 2 if:

- (a) at the Company's annual general meeting for the financial year ended 30 June 2020, the votes cast against the remuneration report considered at that annual general meeting were less than 25%; or
- (b) at this annual general meeting less than 25% of the votes cast on Resolution 1 are voted against adoption of the Remuneration Report.

Voting Prohibition Statements

Resolution 1 – Adoption of Remuneration Report

EXPLANATORY STATEMENT

This Explanatory Statement has been prepared to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions.

1. FINANCIAL STATEMENTS AND REPORTS

In accordance with the Corporations Act, the business of the Meeting will include receipt and consideration of the annual financial report of the Company for the financial year ended 30 June 2021 together with the declaration of the Directors, the Directors' report, the Remuneration Report and the auditor's report.

The Company will not provide a hard copy of the Company's annual financial report to Shareholders unless specifically requested to do so. The Company's annual financial report is available on request.

2. RESOLUTION 1 – ADOPTION OF REMUNERATION REPORT

2.1 General

The Corporations Act requires that at a listed company's annual general meeting, a resolution that the remuneration report be adopted must be put to the shareholders. However, such a resolution is advisory only and does not bind the company or the directors of the company.

The remuneration report sets out the company's remuneration arrangements for the directors and senior management of the company. The remuneration report is part of the directors' report contained in the annual financial report of the company for a financial year.

The chair of the meeting must allow a reasonable opportunity for its shareholders to ask questions about or make comments on the remuneration report at the annual general meeting.

2.2 Voting consequences

A company is required to put to its shareholders a resolution proposing the calling of another meeting of shareholders to consider the appointment of directors of the company (**Spill Resolution**) if, at consecutive annual general meetings, at least 25% of the votes cast on a remuneration report resolution are voted against adoption of the remuneration report and at the first of those annual general meetings a Spill Resolution was not put to vote. If required, the Spill Resolution must be put to vote at the second of those annual general meetings.

If more than 50% of votes cast are in favour of the Spill Resolution, the company must convene a shareholder meeting (**Spill Meeting**) within 90 days of the second annual general meeting.

All of the directors of the company who were in office when the directors' report (as included in the company's annual financial report for the most recent financial year) was approved, other than the managing director of the company, will cease to hold office immediately before the end of the Spill Meeting but may stand for re-election at the Spill Meeting.

Following the Spill Meeting those persons whose election or re-election as directors of the company is approved will be the directors of the company.

2.3 Previous voting results

As at the date of this Notice, the Company has not held its annual general meeting for the financial year ended 30 June 2020 (**2020 AGM**). The 2020 AGM will be held immediately prior to the Meeting.

If, at the Company's 2020 AGM the votes cast against the remuneration report considered are less than 25%, the Spill Resolution is not relevant for this Annual General Meeting and will be withdrawn.

If, at the 2020 AGM, the votes cast against the remuneration report are more than 25%, and at least 25% of the votes cast on the Remuneration Report Resolution at this Meeting are voted against adoption of the Remuneration Report, the Spill Resolution will be relevant for this annual general meeting.

Refer to Resolution 2 and Section 3 for further information.

3. RESOLUTION 2 – SPILL RESOLUTION

Note: The Chair will withdraw Resolution 2 if:

- (a) at the Company's 2020AGM, the votes cast against the remuneration report considered at that annual general meeting were less than 25%; or
- (b) at this Meeting less than 25% of the votes cast on Resolution 1 are voted against adoption of the Remuneration Report.

3.1 General

The Corporations Act requirements for this Resolution to be put to vote are set out in Section 2.2.

The effect of this Resolution being passed is the Company will be required to hold another meeting of Shareholders within 90 days of the date of this Meeting (**Spill Meeting**) and the Vacating Directors will cease to hold office immediately before the end of the Spill Meeting. The business of the Spill Meeting will be to put to vote resolutions to appoint persons to offices vacated by the Vacating Directors.

In the event a Spill Meeting is required a separate notice of meeting will be distributed to Shareholders with details about those persons that will seek election as directors of the Company at the Spill Meeting.

3.2 Proxy voting restrictions

Shareholders appointing a proxy for this Resolution should note the voting restrictions applying to Resolution 1 apply in the same manner to this Resolution.

4. RESOLUTION 3 – RE-ELECTION OF DIRECTOR – JOHN SETON

4.1 General

Listing Rule 14.4 and clause 13.2 of the Constitution provide that a director of the Company must not hold office (without re-election) past the third annual

general meeting following the director's appointment or three years, whichever is the longer.

John Seton, who has served as a Director since 17 December 2018, retires by rotation and seeks re-election.

4.2 Qualifications and other material directorships

Mr Seton is an experienced public company Chairman, director and operational CEO and is a Chartered Fellow of the New Zealand Institute of Directors. John is a commercial lawyer who has practised in corporate and commercial law both in New Zealand and internationally and has extensive experience owning, managing and sitting on the boards of significant public and private business operations in a variety of industries.

John brings a skill set covering corporate and project fundraising (both debt and equity, including a number of public company IPOs), transaction negotiation and management, mergers and acquisitions and steering businesses through periods of significant change.

John has extensive hands-on experience across several industries, including an understanding of corporate governance, the opportunities and pitfalls of markets undergoing change and the value (and limitations) of technology.

4.3 Independence

If re-elected the Board considers John Seton will be an independent Director.

4.4 Board recommendation

The Board has reviewed John Seton's performance since his appointment to the Board and considers that his skills and experience will continue to enhance the Board's ability to perform its role. Accordingly, the Board supports the re-election of John Seton and recommends that Shareholders vote in favour of Resolution 3.
